JOHN TAYLOR BABBITT FOUNDATION GRANT PROGRAM

The John Taylor Babbitt Foundation (“JTB Foundation”) is dedicated to the prevention of sudden cardiac death, including among student athlete populations. The JTB Foundation may periodically make grants available to non-profit organizations for their use in preventing sudden cardiac death through the purchase of automatic external defibrillators (AEDs), CPR/AED training, education and awareness programs, or related activities. There is no specific limit on grant amounts. Applications must include a proposed budget and applicants are strongly encouraged to specifically identify the commitments they propose to make to their selected program, such as providing matching funds, staff time, or other program commitments. (For example, if an organization requests funding for a portable AED to be available at certain events, then the organization should describe their specific procedures for ensuring that the AED will be brought to and available at those events.)

To apply for a grant, please send the following items to info@jtbfoundation.org or by mail to JTB Foundation, Attention Grant Request, P.O. Box 698, Chatham, NJ, 07928:

- Completed and signed Grant Application Form including agreement to Terms and Conditions. The form must be signed by an authorized individual from the applicant organization.
- Letter detailing the desired purpose, use, and amount of the requested grant. This description should include a proposed budget for the activity, a summary of the applicant’s commitment to the activity, an estimate of the number of individuals who will be impacted by the activity, and a summary of the benefits to be achieved.
- Supporting materials for your organization, including history, mission statement, documentation on non-profit status, current financial data, annual report, etc.

Terms and Conditions:

- Grant recipients must be registered non-profit organizations, in good standing, and they must propose to use grant funds for activities that will help prevent sudden cardiac death.
- Any organization that receives a grant must use the funds in a timely fashion exclusively for the stated purpose in their application materials and must fully meet their commitments to the activity as detailed in their application materials.
- Grant recipients are solely responsible for identifying and meeting any and all legal, safety, statutory, tax, and other requirements and regulations associated with their use of the grant funds for the stated purpose and with their implementation of the activity which the grant helps support.
- The grant recipient hereby understands and acknowledges that if a grant is awarded it is solely responsible for the implementation of its program and that the John Taylor Babbitt Foundation is not responsible for the selection, purchase, installation, repair, maintenance, replacement of AED equipment; the training, education or awareness programs implemented by the recipient; or any other activities undertaken by the grant recipient that are associated with the grant recipient’s sudden cardiac death prevention program and hereby releases and forever discharges and holds harmless the JTB Foundation and its affiliates, directors, officers, employees, advisors or agents,

and any other persons or entities acting on their behalf, from any and all liability, claims, damages, and demands of whatever kind or nature, whether direct, indirect, incidental, consequential, special, exemplary, or punitive, either in law or in equity, which arise or may hereafter arise from any activity of the grant recipient, as well as from any suspension, cancellation or modification of the grant program made by the JTB Foundation.
